Contract Terms

1. This Contract is between the Client (the registered shipowner on behalf of whom the Applicant is acting) and the Lloyd's Register Operating Entity which maintains offices in the country or region in which the Applicant (the Client's representative) is based at the time that the Applicant enters into this Contract. Lloyd's Register Operating Entities (LROE) that are affiliates and subsidiaries of Lloyd's Register Group Limited include: Lloyd's Register EMEA, Lloyd's Register Asia and Lloyd's Register North America Inc. and others listed on the link which can be accessed by clicking on the "Show LROE" button below and are hereinafter referred to individually as LR. Classification and survey information displayed on this website is derived from surveys conducted and reported by LR surveyors.

2. In these terms and conditions: (i) "Services" means any and all surveys, classification, certification and reporting services provided at any time to the Client by LR (ii) the "Contract" means this agreement for supply of the Services; (iii) the "LR Group" means LR, its affiliates and subsidiaries, and the officers, directors, employees, representatives and agents of any of them, individually or collectively; "Fees" means all fees and charges invoiced to the Client by any LR Group entity pursuant to the terms of this Contract; and (iv) Committee means the LR Group Classification Committee.

3. The Client agrees to pay all Fees for the Services within 30 days of the invoice date (the due date). If the Client disputes an invoice, or part of an invoice, the Client must immediately notify LR in writing. If no notification is received by the due date, the Client will be deemed to have accepted the invoice in full. Where only part of an invoice is disputed, the undisputed amount must be paid by the due date. LR reserves the right to raise interim invoices for Services provided, calculated on a pro rata basis. LR reserves the right to charge interest accruing on a daily basis at an annual rate of 2% above the greater of the London Interbank Offered Base Rate (LIBOR) (or the equivalent in the country where the Client maintains its principal office) on any amount remaining unpaid beyond the due date, and may withhold any or all Services until the arrears, including interest, are paid in full. LR may at its sole discretion at any time
